# 1. **DEFINITIONS**

## 1.1 Defined Terms

- Bench Officials comprises two (2) scorers, one from each team, who are to be present on the Score Bench for each match and who are members of the Association.
- Constitution means the constitution of Newcastle Netball Association Inc.
- Competition means the Newcastle Netball Association Tri-Series (*herein mentioned as NNA Tri-Series*). The competition may be sponsored and carry the sponsor's name.
- Competition Rules means the rules of the Competition as articulated and referenced within this document.
- NNA means Newcastle Netball Association Inc and is referred to in this document as NNA.
- NNA Tri-Series Committee means a Committee formed consisting of:
  - appointed NNA Tri-Series Manager
  - 1 nominated member of the Umpires Committee
  - 1 nominated coach or player representative from each of the 8 clubs participating in the competition
- Netball NSW means the New South Wales Netball Association Inc. and is referred to in this document as NNSW.
- Player means any person who has a current financial registration with NNSW and who has been registered with the relevant team.
- Score Bench means the official bench for the scoring of matches.
- Team means each of the Club netball teams granted the right to compete in the Tri-Series by NNA.
- Team Officials mean officials involved with the management, preparation and participation of the Team, including the coaches, manager and other support staff and all of whom are members of the Association.

#### 2. ADMINISTRATION

- 2.1 Subject to these Competition Rules, the NNA Constitution and any other document, the NNA Tri-Series Manager shall have the authority to enquire and adjudicate all questions and disputes arising out of this Competition. The item is then to be ratified by NNA Management Team and that decision shall be final.
- 2.2 If a matter is not provided for in this Outline, the Competition Structure, the NNA Constitution or any other document, the NNA Tri-Series Manager may make any determination after consultation with NNA Tri-Series Committee and relevant parties. The item is then to be ratified by NNA Management Team and that decision shall be final.
- 2.3 Any participating Team refusing or neglecting to abide by a decision of the NNA Tri-Series Committee may be excluded from the Competition for such time as the NNA Tri-Series Committee, in consultation with the NNA Management Team, shall determine.
- 2.4 All relevant correspondence shall be addressed to the Association Secretary and marked to the attention of the NNA Tri-Series Manager.
- 2.5 All outward correspondence shall be dispatched from the Secretary or NNA Tri-Series Manager and directed to the Club Secretary by email unless the Club nominates another person to also receive the correspondence.
- 2.6 Competition Rules will be reviewed by NNA Tri-Series Committee at the conclusion of each season or as necessary during the season. Major rule changes will occur every two years. All changes to be ratified by NNA Management Team.

# **3** EXPRESSION OF INTEREST

- 3.1 An Expression of Interest (EOI) will be called by NNA every two years. Interested clubs (current participants or new clubs) will need to
  - (a) submit an EOI by advertised due date and;

(b) accompanied by any supporting documentation and evidence of payment of set application fee.

- 3.2 To enter/re-enter the competition:
  - 3.2.1 Clubs wanting to enter the Tri Series for the first time must meet the following criteria:
    - Demonstrated success in Division1 grades in the NNA Winter Competition in Seniors, 21's, 17's and 15's
    - Demonstrated Club growth in junior base
    - Dedicated personnel to assist in abiding by the Tri Series rules

- 3.2.2 Assessment of Current clubs to continue in the Tri Series will include, but is not limited to
  - Player retention
  - Club growth
  - Adherence to NNA Policies
  - Number of team forfeits
  - Club attendance at Association meetings
  - Assistance with Association media calls and requests for assistance
- 3.2.3 If more than eight (8) teams meet the criteria to join the competition, a playoff will occur in February of the year following the close of registrations at a time and date set by NNA.

The Clubs selected to playoff will be:

- New Club(s); and
- The Clubs placed 7th and 8<sup>th</sup> on the ladder after Round 14, adjusted for the assessment as set out in 3.2.2
- 3.3 Upon acceptance of the EOI, entries for the Competition must be lodged in accordance with the procedures as determined by NNA and distributed with the offer letter.
- 3.4 All entries must be received by NNA by the published time and date for close of entries.

## **3** COMPETITION REVIEW

- 4.1 A review of the competition will be undertaken every 2 years. The next review will be at the end of the 2026 season.
- 4.2 Current participating clubs wishing to continue in competition will need to submit an expression of interest every two (2) years. Continuing participation is not guaranteed as all Clubs must have demonstrated compliance with all Policies and rules of NNA and NNSW and other criteria as set down by NNA.

# 5 STRUCTURE OF COMPETITION

- 5.1 The NNA Tri-Series is conducted as an outdoor competition at National Park Netball Court, Union Street, Cooks Hill.
- 5.2 The commencement dates are those as set out-in the NNA Calendar of Events.
- 5.3 The NNA Fixtures Convenor will make a final decision as to the draw for the scheduling of matches.
- 5.4 The Competition consists of a maximum of eight clubs competing in a three-tier competition with only one (1) club team allowed in each competition level:

NNA Tri-Series Championship NNA Tri-Series Open NNA Tri-Series Under 23s

- 5.5 Each tier of the Competition will consist of fourteen (14) minor round matches followed by a Finals Series for each tier and based on an eight team structure.
- 5.6 Competition points:

Three (3) points received for a win Three (3) points received for receiving a forfeit Two (2) points received for a draw One (1) point received for a loss Zero (0) points received for forfeiting a match Zero (0) points for breaching the borrowed players policy Zero (0) points for an incomplete scoresheet

# 5.7 Forfeits

5.7.1 If a team does not have 5 players present and fails to take the court within one minute of the start of the match, the match will be declared a forfeit. The opposing team will be awarded the match.

#### 5.7.2 Outcome of a forfeit

Non-forfeiting team	<ul> <li>Recorded as a WIN and 3 points allocated</li> <li>All players are recorded as having played</li> <li>Game not included in goal percentage calculations</li> </ul>
Forfeiting team	<ul> <li>Recorded as a LOSS and 0 points allocated</li> <li>No player is recorded as having played</li> <li>Game included in goal percentage calculations</li> </ul>

- 5.7.3 **Abandoned Game** If Team X does not have sufficient players listed on the scoresheet to continue in a match, the match is stopped by the umpires' whistle and is awarded to the other team Team Y. If Team X is winning the game, team X's score will be recorded as one goal less than Team Y's score on the scoresheet at that time.
- 5.7.4 If a team forfeits during the Final Series they are excluded from any further participation in the competition.

#### 5.8 Final Series

5.8.1 At the conclusion of Round 14, the teams in positions 1-4 on the ladder for each tier will progress to a final series as per the NNA Competition Structure.

#### 5.9 Trophies and Medals

- 5.9.1 An overall Club Championship Trophy will be awarded based on the results at end of Round 14 as per the Competition Policy. The perpetual trophy is to be returned by Round 14 of the current season.
- 5.9.2 Presentation of overall Club Championship Trophy will occur at the NNA Awards Dinner at end of season.
- 5.9.3 A Most Valuable Player medal is to be awarded at the conclusion of the season at the NNA Awards Dinner for each of the competition tiers.
- 5.9.4 Teams will nominate one (1) player from the opposing team on the scoresheet at the conclusion of each game, to player whom they deem has played outstandingly in the game, highlighting excellence and exemplariness amongst their peers.
- 5.9.5 Points are collated each round game by NNA Tri-Series Manager.
- 5.9.6 If a team fails to nominate a player from the opposing team it will be deemed an incomplete scoresheet and 0 points will be allocated to that team.

#### 5.10 Match Duration and Match Format

- 5.10.1 Matches will be played in accordance with NNA Competition Structure.
- 5.10.2 Timeslots will be as follows:

NNA Tri-Series Under 23s will play at 11.55am each round NNA Tri-Series Open will play at 1.15pm each round NNA Tri-Series Championship will play at 2.30pm each round

#### 5.11 Fines / Penalties

As set in NNA Competition Structure.

#### 6 PLAYER REGISTRATION

- 6.1 To be eligible to compete in the NNA Tri-Series Competition, a player must be turning 15 years in the year of play.
- 6.2 All players must be registered in PlayHQ.

6.3 Clubs shall enter three (3) teams with a minimum of eight (8) players and a NNA Tri-Series Outline – Version 7

maximum of twelve (12) players into PlayHQ by advertised date set by NNA.

- 6.4 In addition to the NNA individual player registration fees, a Competition fee of \$1,800.00 is set for each Club. This fee contributes towards equipment, the development of umpires, coaches and bench officials and pathway opportunities for players.
- 6.5 A Club is not permitted to have more than twelve (12) players registered at any time in a team within each competition tier.

#### 6.5 Grading of Premier League players

- 6.6.1. A player that is currently under contract with a Netball NSW Premier League Club Opens team in the year of play, is only permitted to be registered in a NNA Tri-Series Championship team.
- 6.6.2 A player that is currently under contract with a Netball NSW Premier League Club 23s team in the year of play, is only permitted to be registered in a NNA Tri-Series Championship or Opens team.
- 6.7 There will be no day registrations allowed.
- 6.8 Transfer of a player

Conditions of Player Transfer:

- 6.8.1 Permission to transfer will only be granted under exceptional circumstances.
- 6.8.2 Transfer will be considered if fewer than three games have been played by the player prior to Round 11, and only once per season per player.
- 6.8.3 A payment of \$10.00 administrative fee to be submitted with completed Player Transfer form .
- 6.8.4 A player may only transfer in the same grade or higher.
- 6.8.5 An official of the registered club releasing the player must sign transfer form.
- 6.8.6 Notification of approval will be given within 5 days of receipt of Player Transfer Request form and payment of said administrative fee.

#### 6.9 <u>Deregistration of a player</u>

On advice from the Club, a player will be detached from the team and will no longer appear on the scoresheet.

#### 7 BORROWED PLAYERS

7.1 Borrowing of players will be allowed as followed:

<u>Championship</u> – a Club's Championship team may borrow from the Club's Opens team and the Club's 23s & Under team.

<u>Opens</u> – a Club's Opens team may borrow from the Club's 23s & Under team.

<u>23s & Under</u> –a Club's 23s & Under team may borrow from any team within their Club or aligned Club/s in the Winter Competition, any player who is turning 15 to 23 years of age in the year of the competition.

- 7.2 A Team must only have 12 players on the bench on any one game day.
- 7.3 A Team is limited to six (6) borrowed players which can be made up of a combination of eligible options from 7.1 above.
- 7.4 Borrowed players from Winter Competition are not eligible to participate in NNA Tri-Series final series.
- 7.5 Borrowed players from Winter Competition will have any Tri-Series games played excluded from their borrowed tally within Winter Competition.
- 7.6 The Winter Competition can not borrow players from the Tri Series Competition.

#### 8 PLAYER ELIGIBILITY – NNA TRI-SERIES REGISTERED PLAYERS

8.1 Players may play up to two (2) matches on any one game day; one of which must be in the grade registered. If a split or rescheduled round occurs a player can still only take the court for their registered team and/or one other match.

8.1.1 A player can only play one (1) match on any given Finals day.

- 8.2 To be eligible to participate in the final series a player-
  - 8.2.1 must be a registered member of a Tri-Series team;
  - 8.2.2 must have been recorded as participating in three (3) minor round matches by taking the court and having their name and position recorded on the scoresheet for a minimum of two (2) quarters per match.
- 8.3 Players that qualify for more than one team, must nominate only one team to play in for the final series such nomination must be made three (3) days prior to the series commencement.
- 8.4 All teams must nominate their teams to take part in the final series or plate series three (3) days prior to the series commencement, in order that eligibility can be checked.

- 8.5 Team lists for Final Series to be published on NNA Tri-Series page on NNA website the day before series commencement.
- 8.6 Any team found playing an ineligible player in the finals series or plate series matches will be considered to have lost the match in which the ineligible player has taken part and the match will be awarded to the opposing team. Any player found to be ineligible to take part in the finals series matches will not be permitted to take any further part in the series.
- 8.7 It is the responsibility of the Club to manage team lists and be aware of players playing higher divisions which may result in finals eligibility.

# 9 MARKETING AND PROMOTION

# 9.1 Members:

- 9.1.1 grant NNA Administrators the non-exclusive right to use your name or image in any medium for netball marketing and promotional activities;
- 9.1.2 must respond to any request by the NNA to participate in a promotional or game development activity, including personal appearances for sponsors or coaching clinics (provided you are able to attend); and
- 9.1.3 must co-operate with NNA, the media (in particular the holders of any broadcast rights), sponsors or any other person reasonably required in relation to any promotional activity.
- 9.2 Members must not:
  - 9.2.1 participate in any personal promotional activities if the products or business of that personal sponsor are in competition with the products or business of a NNA Sponsor;
  - 9.2.2 use any NNA intellectual property rights, in particular any names, logos or playing apparel (other than in accordance with this Policy); and
  - 9.2.3 engage in any marketing or promotional activities that may bring a NNA Administrator or the game of netball into disrepute.
- 9.3 Members are not obliged to participate in promotional activities if you (acting reasonably and in a bona fide manner) have:
  - 9.3.1 a moral or religious objection to any use that may be made of your image and have declared that objection; or
- 9.3.2 work, education or personal commitments. NNA Tri-Series Outline – Version 7

#### **10 TEAM OFFICIALS**

The Club must submit details of Team Officials at the time of team entry.

#### **11 MATCH OPERATIONS**

- 11.1 Equipment Scoresheet and a Match Ball-supplied by NNA.
- 11.2 Scoresheets
  - 11.2.1 The Scoresheet must include the seven (7) players and their on-court positions, and up to five (5) player reserves. Names of borrowed players to be written on scoresheet prior to game commencement.
  - 11.2.2 Player substitutions during a match are to be recorded on the Scoresheet and are to be provided to the Bench Officials as soon as possible after the substitution has occurred.
- 11.3 Uniform refer to clause in Competition Structure.

#### 12 ADVERSE WEATHER CONDITIONS

- 12.1 Games affected due to adverse weather conditions refer to the NNA Adverse Weather Conditions Policy.
  - 12.1.1 Additional Designated Adverse Weather Days for the Tri Series competition will be determined at the start of each season and in consultation with the Tri Series Committee.

#### **13 ISSUES ON COURT**

13.1 If there is an issue on any court before or during a match, please report it to the NNA office in person. If you are unable to leave the court, please send a representative in order that the matter can be dealt with in a timely manner.

#### **14 COMPLAINT HANDLING**

- 14.1 Clubs are to be familiar with current complaint and disciplinary procedures and advise their members accordingly.
- 14.2 Clubs, as affiliates are expected to manage all matters of complaint or incident in accordance with the relevant Netball NSW policies.

- 14.3 Clubs are encouraged to have their own Member Protection Officer (MPIO) or be able to provide their member with details of an MPIO before lodgement of a complaint on incident.
- 14.4 A 'complaint' in this context is considered to include grievances, disputes and member protection issues.
- 14.5 All complaints will be reviewed and managed in accordance with the relevant Netball NSW policy and procedure.
- 14.6 All complaints are to be submitted to the NNA Secretary by the Club using the designed form.
- 14.7 All complaints will be treated as confidential; this includes correspondence and the process in which the complaint is handled.
- 14.8 The NNA Secretary, or delegate will assess the complaint before determining appropriate action to be taken.
- 14.9 In instances where a complaint is lodged to register indecent/s but no action requested or warranted, the club will be asked to take the appropriate steps toward resolution in accordance with Netball NSW policies. It will be the club's responsibility to follow up this type of complaint.
- 14.10 The club will provide a report to the NNA Secretary of the actions taken and outcome.
- 14.11 Non-members are not permitted to submit complaints for review by NNA using the Netball NSW policies and procedures.

#### **15 DISCIPLINARY PROCEDURE**

- 15.1 Disciplinary procedures are considered those in context to on-court conduct and offences.
- 15.2 Incidents must be reported using the designated form and are to submitted to the NNA Secretary.
- 15.3 Incidents will be reviewed and managed in accordance with the relevant Netball NSW Policy. This may include no action by NNA, a directive for the club to manage or progress to tribunal.
- 15.4 Clubs are to be familiar with the procedures and advise their members on appropriate actions and requests and possible outcomes.
- 15.5 The club will provide a report to the NNA Secretary of the actions taken and outcome.
- 15.6 Non-members are not permitted to submit incident reports for review by NNA using the Netball NSW policies and procedures. They may at times be requested to provide statements.

# **16 APPEALS**

All appeals to complaints procedures will be managed in accordance with the Netball NSW policies and procedures.
